RESPONSE TO VENDOR QUESTIONS

Vendor Question No. 1:

For the Bathroom walls, under 3.2.7.1 It states to use a 6x6 porcelain tile from Stonepeak - style: Simply Modern. Simply Modern does NOT offer a 6x6 tile. They offer a 12x12 & a 12x24. What do we bid in this case? If we use a larger size for the walls it will generate a larger weight load on the walls, Therefore we will need to cut the paneling/drywall out 3'6" high and replace it with concrete board so the tile will not fall off the walls.

Agency Response:

Contractor may cut approved tile to size. Damaged tile will not be accepted. All current bathroom walls are plywood construction. Sheetrock is to be installed above the wall tile. All tile is to be installed per manufacturers recommendations. All vertical surfaces (tile and sheetrock) must be even.

Vendor Question No. 2:

For the Bathroom walls, under 3.2.2 it also states to use a 2x6 tile rail. Stonepeak - style: Simply Modern does not offer a rail. Do you want me to quote something that matches? Or do you have a specification of another manufacturer and style name?

Agency Response:

Contractor may cut approved tile to size. Damaged tile will not be accepted.

Vendor Question No. 3:

For the Kitchen floors, under 4.1.6.l it states to use Stonepeak tile, but does NOT state the style name to use. Do you want to use the same style as the bathrooms? (ex: Simply Modern)

Agency Response:

Color of tile will be selected by agency from approved manufacturer's available colors.

Vendor Question No. 4:

For the Kitchen backsplash, it does not state what manufacturer or style or size to use.

Agency Response:

Bid specifications are clear on this. A 4" countertop backsplash is specified in same color and material as countertop. Pattern is to be selected by agency.

Vendor Question No. 5:

My supplier cannot order "Anderson" windows as specified in the bid documents. Is there a similar brand name widow that will be a close specification?

Agency Response:

No other suggested window manufacturers will be provided, but alternative brands must equal the specifications in the bid.

Vendor Question No. 6:

None of my paint suppliers can meet the brand or specifications that you are requesting. Can you provide a different type/style of paint to meet your required specifications?_Note: although it may be impossible, we are trying to establish a supply vendor that can accommodate all of the items from a single source because of our credit account with that particular vendor. My vendor is Lowe's. If we can provide item specifications for all items that will come from them, that would be great. We can venture out to other suppliers for minimal cost items.

Agency Response:

No other suggested paint manufacturers will be provided, but alternative brands must equal the specifications in the bid.

Vendor Question No. 7:

- 9. Added Alternate 4 Replace Roofs (cabins #1, 2, 3, 4, 5, & 6)
- 9.1 Replace roof with shingles of existing type and color.
- 9.2 Leave gutters unless damaged while installing roofing.
- 9. 3 Must install proper felt under roofing shingles.
- 9.4 Use existing flashing or replace by inserting the new flashing into chimney by grinding and sealing flashing into stone and stepping down the flashing to overlap for leak prevention.

- 1. Can we substitute the shingles with metal roofing? Installing shingles in the winter is not recommended by any shingle manufacturer when temperatures are below 40 degrees. The shingles will not properly bond to created a water tight seal. High blowing winds can also create a blow-off of the shingles when not sealed properly. We will suggest the .29 GAUGE raised rib panels that are adhered using neoprene washer screws. This would also reduce costs as the old shingles would not have to be torn off.
- 2. If we are not allowed to install metal roofing, can we substitute the existing three tab shingles with an architectural/dimensional shingle? An example would be the "Owens Corning Oakridge" style of shingle.

Agency Response:

Response to above questions #7-1: Specified shingles must be used, metal roofing is not approved.

Response to above question #7- 2: Yes, "Owens Corning Oakridge" architectural/dimensional shingle is approved.

Vendor Question No. 8:

- 8. Added Alternate 3 Repair Rotted Logs on Cabin #6
- 8.1 Repair rotted logs on Cabin 1#6 on the bottom logs, right side of cabin facing hillside.
- 8.2 Provide new Log and chinking at specified location.
- 8.3 Finish logs and chinking to match existing interior and exterior. Log diameters should match log being replaced.

Ouestions:

- 1. Do you have a source for the logs and chinking material that you have used in the past?
- 2. Do you know the type (species) of log that is there now?
- 3. Do you know the type of chinking material that is currently in place?

Agency Response:

Response to question #8-1: No source for logs.

Response to question #8- 2: Mostly Chestnut, which is extinct now. Alternative species is acceptable.

Response to question #8- 3: No, most original chinking was cement based or a pre-cement era mixture of ash, sand, lime, etc. Synthetic or cement base chinking will be acceptable. Chinking must be installed per industry standards and/or manufacturers recommendations.

Vendor Question No. 9:

We would like to send a company representative to the park to measure each cabin for the ceramic flooring and walls. Would that be possible?

Agency Response:

You may visit the parks to take measurements prior to the bid closing dates. Please understand that staff is not able to answer specific technical questions as the technical Q&A deadline has passed, but you are welcome to look and measure as able. You may contact Babcock State Park at 304-438-3004, to coordinate a day and time to get measurements.

Vendor Question No. 10:

Is there a "vendor preference form" that can be attached to the bid submission documents where contractors that qualify can request preference status of the bid submitted, such as, woman-owned business, veteran-owned business, etc?
